Course Objectives:

This course is designed to give Economics Honours Students a deeper understanding of modern econometrics tools. A primary focus of the course is on providing extended practical experience in estimating econometric models using real-world data sources. The topics that we will cover include: 1) theoretical properties of econometric models designed for different data structures; 2) empirical applications of these techniques, and 3) skills for data analysis. Specific areas of study include Time Series Analysis, Panel Data Analysis, Instrumental Variable (IV)

Estimators, Simultaneous Equations Models, and Limited Dependent Variable Models. The course presumes that students are familiar with elementary calculus and linear algebra. The software STATA will be used for empirical analysis. More details about the software and lab sessions will be provided during the course.

Course Learning Outcomes:

Students who successfully complete the course will learn how to:

- analyze data sources used in empirical research.
- analyze econometric techniques used on different types of data.
- apply these techniques to real-world data sources using STATA.
- interpret parameter estimates from different econometric models.

formulate econometric models to answer empirical questions.

Textbooks:

Wooldridge, Jeffrey (2015): Introductory Econometrics: A Modern Approach, 6th edition, South-Western.

Note: The 5th edition of this textbook is virtually identical for our purposes, as are earlier ones. Several copies of this textbook are on reserve at Weldon

Grading:

- Assignments (15%)
- Two exams (25% each)
- Final exam (35%)

Homework assignments are due at the start of class on the due date. Late assignments, and assignments not handed in will receive a grade of zero. The best five score out of the six assignments will count towards your grade.

The midterm exams will be held on Monday, Oct. 1 and on Monday, Nov. 12 in the normal classroom (SSC 3026). There will not be any make-up tests for the exams. If you are unable to take an exam for a medical reason and provide appropriate documentation for it, its weight will be added to the final exam. The time and location of the final exam will be announced in class.

Course Outline:

Adjustments to the course schedule will be made as needed, and will be announced in class.

Electronic Devices:

The only electronic device you may use during exams is a non-graphing, non-programmable calculator. Graphing/programmable calculators, cell phones, etc. must be kept in your bag. If you have any of these devices out during an exam they will be taken from you and will only be returned once you have turned in the exam.

Western University uses software to check for plagiarism and students may be required to electronically submit their work. Those found guilty will be penalized as noted in point 3.

The Department will not consider an appeal unless an attempt has been made to settle the matter with the instructor first. Students who remain dissatisfied with the outcome may proceed with a written appeal (e-mails are not acceptable) to the Undergraduate Director in Economics, stating the reasons for their appeal. 9. Faculty of Social Science policy states that oversleeping or misreading an exam schedule is NOT grounds for a makeup. This rule applies to midterm and final exams in the Department of Economics.

Policy Regarding Makeup Tests and Final Examinations

Academic accommodation will **not** be granted automatically on request. Students **must** demonstrate by documentation that there are **compelling** medical or compassionate grounds before academic accommodation will be considered.

Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or having their value reweighted on a retroactive basis, is **not** permitted. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with test or final exams.

Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within **24 hours** when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor. If the instructor is not available, send an email message, copying the Undergraduate Coordinator at <u>econugrd@uwo.ca</u>. Notifying instructors of a missed exam does not automatically entitle students to a makeup.

Students who seek a makeup exam must also provide supporting medical or other relevant documentation that their absence from a scheduled test or exam is beyond their control. Documentation should be submitted to the Academic Counselling Office of the student's *home* Faculty **as soon as possible (preferably within 24 hours of the scheduled test)**. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. If the documentation submitted is not acceptable, students will receive a zero for the missed test.

For personal illness, students may consult Student Health Services and request a Student Medical Certificate from the physician. If assessed by an off-campus doctor, students must obtain a certificate from his/her office at the time of the visit. The off-campus medical certificate form must also be used and can be found at: <u>http://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf</u>. Notes stating "For Medical Reasons" are not considered sufficient.

For religious or compassionate circumstances, students should ask their Academic Counsellor what documentation to provide. If documentation is judged sufficient, the Academic Counsellor will issue a Recommendation for a Special Examination (a single form for midterms or a triple-

color form for final exams). Once students have this form, they must contact their instructor as soon as possible to make arrangements. Even if approved by their Academic Counsellor, there is no guarantee that students will be allowed to write the makeup test/exam.

For final examinations, students need to seek permission from their *home* Faculty Counsellor, Instructor, and the Department Undergraduate Director. Failure to follow this procedure may result in a grade of zero. Students must ensure that the Special Examination form has been signed by the Instructor and Department Undergraduate Director and that the form is returned to the Academic Counselling Office for approval without delay. If approved, makeup examinations will be written within one month of the end of the exam period.
