## **Registration:**

## Prerequisite/Antirequisite Note:

The prerequisites for this course are: (i) Economics 1021A/B and 1022A/B; or (ii) 0.5 from Mathematics 1225A/B, Mathematics 1230A/B, Calculus 1000A/B, and 0.5 from Mathematics 1229A/B, Mathematics 1600A/B, Calculus 1301A/B; or (iii) Calculus 1501A/B.

This course cannot be taken concurrently with or prior to taking Data Science 1000A/B as they will become antirequisites to one another in these sequences.

You are responsible for ensuring that you have successfully completed all course prerequisites, and that you have not taken any anti-requisite courses. Lack of prerequisites may not be used as a basis for appeal. If you are found to be ineligible for a course, you may be removed from it at any time and you will receive no adjustment to your fees. This decision cannot be appealed.

If you find that you do not have the course prerequisites, it is in your best interest to drop the course well before the end of the add/drop period. Your prompt attention to this matter will not only help protect your academic record, but will ensure that spaces become available for students who require the course in question for graduation.

## **Course Description & Objectives:**

This is an introductory course in probability and statistics. The main goal is to teach students how to use statistics and basic economic theory to read and interpret data. This knowledge is paramount to learn how to use math and economics to understand the real world.

## **Course Learning Outcomes:**

At the end of this course students should be able to: (i) interpret tables, graphs, and statistics used for describing data; (ii) apply probability theory to model random variables; (iii) estimate population parameters using point and interval estimators; (iv) evaluate and describe the properties of an estimator; and (v) test theories about population parameters (determine an appropriate test statistic; implement a formal hypothesis test and interpret the outcomes).

## **Textbook(s) and Course Materials:**

Newbold, P., Carlson, W., and B. Thorne. Statistics for Business and Economics (Eighth edition), Prentice Hall (2011). (NCT8)

This textbook is not required, as my lectures are designed to be self-contained. But some students might find the text useful to follow along. Note that, while NCT8 is at the bookstore, the Seventh edition (NCT7), which you may be able to find used for a cheaper price, is a close substitute for the Eighth edition textbook. I will indicate the relevant material from both NCT7 and NCT8 for you to read.

## **Course outline:**

This is a tentative outline of our course, with book chapter references in parentheses (NCT7 and NCT8 use the same chapter numberings). The outline may be adjusted based on our progress. Note that material in lectures may not be in the textbook but may still appear on exams.

- 4. Linear regression, time permitting (NCT 11)

## **Assessments and Grading:**

There are graded homeworks, midterms, and a final exam.

**Homeworks**: There are 3 graded homeworks, each of which will cover recent material. Homeworks will be posted on the course website one week before their due dates, which are October 5, October 26, and November 30. You must print out your homework assignment to turn it in. Late homeworks are forfeited; a homework assignment is considered late if it has not been turned in to me by 3:30pm on the day it is due. For convenience, I will collect homeworks at the start of class on their due dates. The lowest homework score will be dropped.

**Midterm 1:** 2-hour exam held outside of class. Wednesday, October 11, 7-9pm (location TBA). **Midterm 2:** 2-hour exam held outside of class. Wednesday, November 8, 7-9pm (location TBA).

**Final exam:** This exam will be 2.5 hours. The date and time will be set later this semester by the Registrar's office. The course grade is computed using the following weights:

All exams are cumulative. There will be no make-up mid-term exams. If a student misses a midterm due to sickness or other acceptable excuse the student must present an official document justifying the absence and the weight of that exam will be added to the one of the final exam. This document must be submitted to me within one week of the scheduled mid-term. In case of lack of justification for the absence, a grade of zero will be attributed to that exam.

The following re-weighting rule applies to all students who have taken all three exams. If the final exam grade is higher than the lower midterm grade, the weight of the lower midterm will be reduced to 15%, while the final exam weight will be increased to 50% (all other weights remain the same). The re-weighting rule provides a way to improve your overall grade if you perform better on the final. This re-weighting rule does not apply to students who miss an exam.

You may submit an exam or homework for a regrade within one week of when it has been handed back in class but note that I may scrutinize the entire exam or homework during the regrade. This means your grade may go up, go down, or stay the same.

- **Rewriting Exams and Retroactive Reweighting are NOT Permitted:** Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or retroactive reweighting of marks, is **not** permitted. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with tests or final exams.
- Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within **24 hours** when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor. Notifying instructors of a missed exam does not automatically entitle students to a makeup.
