Registration:

You are responsible for ensuring you are registered in the correct courses. Prerequisite Note:

The prerequisite for this course is **Economics 2260** (together with the mathematics prerequisites for that course). The anti-requisite for this course is Economics 2151.

You are responsible for ensuring that you have successfully completed all course prerequisites, and that you have not taken any anti-requisite courses. Lack of prerequisites may not be used as a basis for appeal. If you are found to be ineligible for a course, you may be removed from it at any time and you will receive no adjustment to your fees. This decision cannot be appealed.

If you find that you do not have the course prerequisites, it is in your best interest to drop the course well before the end of the add/drop period. Your prompt attention to this matter will not only help protect your academic record, but will ensure that spaces become available for students who require the course in question for graduation.

Course Objectives:

This course studies the advantages and disadvantages of the different institutions which allocate resources. First, we will discuss various social criteria for judging the outcomes produced by such institutions. Second, we will study perfectly competitive markets and compare their outcomes to the social criteria. Third, we will study situations in which such markets cannot operate because of market power or externalities. Finally, we will study situations in which such markets cannot operate because of asymmetric information.

Course Learning Outcomes:

As a result of taking this course, the students will [a] understand the basic microeconomic concepts and tools that are required for more advanced specialized economics courses, and [b] be able to apply these concepts and tools to analyze real-life economic situations. More specifically, students will learn and be able to explain Pareto efficiency, social welfare, competitive equilibrium, market power, collusion, price discrimination, externalities, Nash equilibrium, dominant-strategy equilibrium, public goods, and asymmetric information. Further, students will be able to perform qualitative predictions of how market outcomes depend on market power, externalities, and asymmetric information, and to identify circumstances in which government interventions or alternative allocation mechanisms would improve social welfare.

Textbook(s):

The required textbook is Varian (2014) *Intermediate Microeconomics with Calculus*, Norton. The accompanying workbook is recommended but not required. That workbook is Bergstrom and Varian (2014) *Workouts in Intermediate Microeconomics (ninth edition)*, Norton.

Grading:

There will be in-class midterms on January 25, February 13, and March 15. Each midterm will determine one sixth of the course mark, and the final will determine the remaining half.

Tentative Outline:

- 1. Welfare (chapters 34, 14, 15). Preference aggregation, Condorcet paradox, Arrow's impossibility theorem, Pareto efficiency, social welfare, Rawlsian justice, utilitarianism, quasilinear preferences.
- 2. Market Equilibrium (chapters 16, 32, 33). Review of supply and demand, partial equilibrium, comparative-statics policy analysis, general equilibrium.
- 3. Market Power and Externalities (chapters 25-30, 35). Monopoly, monopsony, oligopoly, collusion, price discrimination, externalities, game theory, Nash equilibrium.
- 4. Asymmetric Information (chapters 18, 37, 38). Mechanism design, auctions, dominant-strategy equilibrium, public goods with incomplete information, VCG mechanisms, adverse selection, moral hazard.

Important Notes:

- 1. Cameras, phones, and the internet are prohibited during lectures.
- 2. There are no make-up examinations for the midterm examinations. If a student must miss a midterm examination for a legitimate reason (see note #3 below), the missed midterm's weight will be shifted to the final examination.
- 3. In all but highly unusual situations, the reason for missing a midterm examination must be reported and verified by the instructor *before* the examination begins. Failure to follow this procedure will probably result in a zero for the midterm examination.
- 4. Prior travel arrangements do not provide grounds for make-up final examinations. So it is risky to make travel arrangements before the registrar announces the final-examination schedule.
- 5. A make-up final examination may have any format.

- 4. **Plagiarism:** Students must write their essays and assignments in their own words. When taking an idea/passage from another author, it must be acknowledged with quotation marks where appropriate and referenced with footnotes or citations. Western University uses software to check for plagiarism and students may be required to electronically submit their work. Those found guilty will be penalized as noted in point 3.

- 5. It is a Department of Economics policy that **NO** assignments be dated, stamped or accepted by staff. Students must submit assignments in class or to the instructor during office hours.

The Department will not consider an appeal unless an attempt has been made to settle the matter with the instructor first. Students who remain dissatisfied with the outcome may proceed with a written appeal (e-mails are not acceptable) to the Undergraduate Director in Economics, stating the reasons for their appeal. 7. Systematic adjustments of a class grade distribution (either up or down) can occur in Economics courses. The fact that grades have been adjusted is **not** grounds for an appeal.

9. Faculty of Social Science policy states that oversleeping or misreading an exam schedule is NOT grounds for a makeup. This rule applies to midterm and final exams in the Department of Economics.

Policy Regarding Makeup Tests and Final Examinations

Academic accommodation will **not** be granted automatically on request. Students **must** demonstrate by documentation that there are **compelling** medical or compassionate grounds before academic accommodation will be considered.

Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or having their value reweighted on a retroactive basis, is **not** permitted. Students must also book travel arrangements AFTER final exam dates have been posted as they must not conflict with test or final exams.

Unless medically incapable of doing so, students must notify their instructor prior to the test date or at least within **24 hours** when requesting a makeup exam. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. Students should also set up an appointment as soon as possible to meet with their instructor. If the instructor is not available, send an email message, copying the Undergraduate Coordinator at econugrd@uwo.ca. Notifying instructors of a missed exam does not automatically entitle students to a makeup.

Students who seek a makeup exam must also provide supporting medical or other relevant documentation that their absence from a scheduled test or exam is beyond their control. Documentation should be submitted to the Academic Counselling Office of the student's *home* Faculty **as soon as possible (preferably within 24 hours of the scheduled test)**. Failure to follow this procedure may result in denial of academic accommodation and a grade of zero. If the documentation submitted is not acceptable, students will receive a zero for the missed test.

For personal illness, students may consult Student Health Services and request a Student Medical Certificate from the physician. If assessed by an off-campus doctor, students must obtain a certificate from his/her office at the time of the visit. The off-campus medical certificate form must also be used and can be found at:

Notes stating "For Medical Reasons" are not considered sufficient.

For religious or compassionate circumstances, students should ask their Academic Counsellor what documentation to provide. If documentation is judged sufficient, the Academic Counsellor will issue a Recommendation for a Special Examination (a single form for midterms or a triple-color form for final exams). Once students have this form, they must contact their instructor as soon as possible to make arrangements. Even if approved by their Academic Counsellor, there is no guarantee that students will be allowed to write the makeup test/exam.

For final examinations, students need to seek permission from their *home* Faculty Counsellor, Instructor, and the Department Undergraduate Director. Failure to follow this procedure may result in a grade of zero. Students must ensure that the Special Examination form has been signed by the Instructor and Department Undergraduate Director and that the form is returned to the Academic Counselling Office for approval without delay. If approved, makeup examinations will be written within one month of the end of the exam period.
