Course Objectives:

This course is designed to give Economics Honours Students a deeper understanding of modern econometrics tools. A primary focus of the course is on providing extended practical experience in estimating econometric models using real-world data sources. The topics that we will cover include: 1) theoretical properties of econometric models designed for different data structures; 2) empirical applications of these techniques, and 3) skills for data analysis. Specific areas of

study include Time Series Analysis, Panel Data Analysis, Instrumental Variable (IV) Estimators, Simultaneous Equations Models, and Limited Dependent Variable Models. The course presumes that students are familiar with elementary calculus and linear algebra. The software R will be used for empirical analysis. More details about the software and lab sessions will be provided during the course.

Course Learning Outcomes:

Students who successfully complete the course will learn how to:

- analyze data sources used in empirical research.
- analyze econometric techniques used on different types of data.
- apply these techniques to real-world data sources using R.
- interpret parameter estimates from different econometric models.
- formulate econometric models to answer empirical questions.

Textbook(s) and Course Materials:

Wooldridge, Jeffrey (2015): Introductory Econometrics: A Modern Approach, 7th edition, South-Western.

Note: The 5th and 6th editions of this textbook is virtually identical for our purposes, as are earlier ones. Several copies of this textbook are on reserve at Weldon.

Assessments and Grading:

- Assignments (9%)
- Two exams (31% each)
- Final exam (29%)

Homework assignments are due at the start of class on the due date. Late assignments, and assignments not handed in will receive a grade of zero. The best five score out of the six assignments will count towards your grade. Late assessments with illness self-reports must be submitted within 24 hours of submission of the last illness self-report.

The midterm exams will be held on Monday, Oct. 4 and on Monday, Nov. 15 in the normal classroom (SSC 3010). There will not be any make-up tests for the exams. If you are unable to take an exam for a medical reason and provide appropriate documentation for it, its weight will be added to the final exam. The time and location of the final exam will be announced in class.

You may submit an exam for a regrade within one week of when it has been handed back in class; since I may scrutinize the entire exam during the regrade, your grade may go up, go down, or stay the same. Exams are "closed-book". The only electronic device you may use during exams is a non-graphing, non-programmable calculator. Students are forbidden from using any books, notes, study guides, diagrams, communication equipment such as a cell phone, computer software, online resources or websites, or other aids unless authorized by the instructor; such authorization must be stated explicitly during the examination.

Policies Regarding Academic Accommodation

- Accommodation for Students with Disabilities: Students with disabilities or accessibility challenges should work with Accessible Education (formerly SSD, see http://academicsupport.uwo.ca/accessible_education/index.html), which provides recommendations for accommodation based on medical documentation or psychological and cognitive testing. - **Rewriting Exams and Retroactive Reweighting are NOT Permitted:** Students who proceed to write a test or examination must be prepared to accept the mark. Rewriting tests or examinations, or retroactive reweighting of marks, is **not** permitted. Self-Reported Absences cannot be used once a student has proceeded to start to write a test or exam.
- Self-Reported Absences: Students will have two opportunities during the fall and winter terms to receive academic consideration if they self-report a missed assessment using the online self-reported absence portal, provided the following conditions are met: the assessment is missed due to an absence of no more than 48 hours in duration, and the assessment for which consideration is being sought is worth 30% or less of the student's final grade. Students are expected to contact their instructors within 24 hours of the end of the period of the self-reported absence, unless noted otherwise on the syllabus. Students are not able to use the self-reporting option in the following circumstances:
 - for exams scheduled by the Office of the Registrar (e.g., final exams)
 - absence of a duration greater than 48 hours
 - assessments worth more than 30% of the student's final grade
 - if the student has opened or started the test or exam
 - if a student has already used the self-reporting portal twice during the fall/winter terms

If the conditions for a Self-Reported Absence are *not* met, students will need to provide a Student Medical Certificate (SMC) if the absence is medical or provide appropriate documentation if there are compassionate grounds for the absence in question. Students are encouraged to contact their Faculty academic counselling office for more information about the relevant documentation. It is strongly recommended that students notify the instructor as soon as possible, ideally before the assessment, when they become aware of an absence. University policy is that students must communicate with their instructors no later than 24 hours after the end of the period covered by the SMC or immediately upon their return from their documented absence. Failure to follow University policy and procedures may result in denial of academic accommodation and a grade of zero.

- Documentation for Accommodation: Individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds or for other reasons.
